General Report Comments: Whilst writing, Chong-zu kept complaining about the situation. I then asked whether she would sign, and she got angry and said "No, if you can write a letter to me that I must sign, I can write one to you too.". She then went inside the house to fetch paper and started writing a letter. After a while, I realized that she was writing an extremely long letter. She then told her worker that she may leave and do her duties since she was going to write this letter for more than 30 minutes and its our 'job' to wait for her to finish. I then asked her whether she can email this to me or call us so that I can fetch it the following day and she was offended by this. I told her we have other obligations to get to and she is more than welcome to send another email or call us the following day to fetch the letter. I asked her once again whether she was going to sign the warning, but she diverted the conversation. I then told her we have other matters to attend to and I will write that she is not willing to sign the warning. As I started writing this on the warning, she grabbed the Warning book from me and started writing by the "Signature". She wrote: "I am writing something to E Graham, but she couldn't wait, she just very rude and treat me as a prisoner. Sign or not sign and they have to go". I issued Warning 039 to :

1) At the time of our inspection:
Most of the cages had excess faeces, excess food and built-up algae on the floor/walls. Ensure to clean all the enclosures where birds are kept properly within 6 days. After this is done, the faeces and food need to be picked up/cleaned daily. "
I gave Chong-zu her copy of the warning and told her we will be back next Tuesday. We then left the property.

To do follow up on andamar stables horses tomorrow.
