General Report Comments: Hugh and I Elani arrived at the business property. We went inside the office to speak with the owners and ask whether they know about a dog on their property or use security company that uses dogs. They were hesitant at first to admit they are using a security company with dogs. I had to show them photos of the dog and only after pushing them they said that they use Ndombo Security Services. They also admitted that the fence in the photo are their companys fence. This security company brings the dog to work in the evenings from 18h00 to 06h00. The boss then mentioned that on weekends they keep the dog there from the Friday to Monday morning. I then asked the owner to take me to where they keep the dog over the weekends. He took me to the right side of the company and showed us a movable security post. Inside was a bowl filled with dog food. No security guards are on site during the day.

I went back inside to the office and started issueing a watning . The staff asked me what is wrong and I explained everything to them that I wrote on the warning. I also got the zecurity companies details from Mrs Rossouw. I issued a warning to:
Addrss the following within 10 days:
1) It was observed that the security guard on duty during the weekend chained the dog to th ecomooanys fence. This is unacceptable for a working dog. Cease to do this immediately.
2) It was noted that the security dog used over the weekend have no resting enclosure with a kennel and water on the premises, which means the fog works 24 hours a day on the weekend. Cease working security dogs immediately until this is rectified.
3) Probide the Wellington SPCA with you Performing Animals Protection Act licenseapplication within 14 days. Email it to inspectorate@wellingtonspca.co.za
