The owners of Bully that needed to provide a sleeping area complied by taking a blue drum, putting it on its side and a blanket inside. They placed this shelter on their covered stoep and cleaned all the sponge. NFA

Owner of two dogs on running chains. They built running chains for both dogs but did not buy dog food for the dogs. The black dog also had a chain around its neck. Because of the compliance of the runnings chains, we gave the thin dog dewormer and gave a collar to the black dog. I still issued a warning which Lawrence signed to:
1) Provide both dogs with adequate food within 72 hours. Preferably puppy food.
