We then noticed the other dog was tangled on his runner.When asked why he moved the runner he mentioned that somebody came and took it away.We then showed him how to ensure that the dog does not tangle himself.We were then pleased.

We then went back to Magrieta Kruger and saw Lady ,she was extremely underweight.We then explained to them that if Lady does not gain weight in 3 weeks they should make a call because there could possibly be something wrong with her.
