- 4.You can also enclose your yard to let Stacey roam freely by closing all the gaps in the fence .(you can also purchase nexguard/bravecto to help with skin condition)

We then left and arrived at the home where polar stays.We called in the front of the house and the owner then allowed us access.We noticed she complied with everything and polar seems way happier.

We then went to Denise Beukes and noticed Bonzo is still on a static chain and also living in filthy environments.We asked one of the tenants whether Denise was there and he mentioned she had left.

Warning 053 was then left on the gate to:

- 2.Provide Bonzo with an adequate collar(piping on chain,belt,strong collar)
- 3.Ensure to clean Bonzo's living environment from faeces and hazardous material within 72 hours.
