General Report Comments: Elani and I,Hugh arrived at the farm and we walked to Ashley Beukes house.We then arrived at the property and greeted,we then got a response from Ashley Beukes familymember (Chane Williams).We then asked her if Ashley was there and she mentioned that he was at work and was going to build the runner today.We then told her that the dogs skin condition needs to be treated.She then mentioned that we should call him but seemed hesitant to give his phone number when asked.

We then explained to her that we are going to write the final warning and if he does not comply we will have to confiscate the dog since it seems that she has a skin condition and the dog is still on a static chain.The tenant then mentioned that we should rather speak to Ashley Beukes but still seemed hesitant to give his number.

Elani then started writing a warning and while she was busy writing Ashley Beukes arrived seemingly annoyed.He then started explaining he works alot and cannot have the time to fix the fencing. Elani then explained to him that he would take a while to fix the fencing and that she only expects him to build a running chain.While she was explaining he(ashley beukes)grabbed the dog and took the collar off and said we should just take the dog and leave his property .I,Hugh then picked the dog up and he told us that we need to leave as he's boss does not even know he slipped away from work.When asked whether he wants to sign our surrender form he refused and said we should leave.

We then left with Stacey and Elani mentioned that she's going to check on the other chained dog.I,Hugh then walked with Stacey to the bakkie and the owner Ashley walked with me and told me that the Lord will deal with us and we just want to come and do as we please.I then tried calming him down and explained to him that we cannot leave this dog here with this apparent skin condition.He himself mentioned he does not have time for his dog and that he works too much which means he will basically never have time to build the runner,treat the dog and neither fix the fencing.

Elani left to Denise Beukes house to check on Bonzo and she noticed that Bonzo was still on a static chain,living in parasitic environments and had chain around its neck.

Elani then called from the gate and her daughter Angel arrived. She then told her that she will be writing the final warning as we have discussed with her mother what our expectations are.Angel mentioned that the runner which they have at the bottom before entering the house floods and Elani told her that they should just move the runner upwards.

She then wrote the final warning and mentioned to her that we will confiscate the dog if they do not make any changes to the living conditions of the dog.

Final Warning 057 was issued to:

- 1.Provide Bonzo with an adequate running chain within 72hours.
- 2.Provide Bonzo with an adequate collar(piping/belt/proper collar) within 72hours.
- 3.Remove hazardous material in Bonzos environment within 72hours.
