General Report Comments: Hugh and I, Elani arrived at the facility and met with Karen again. She informed us that Dimitri got the email yesterday and that she informed him of our visit on the day, Tuesday.

I asked Karen to show us the food for the animals. In the restuarant they keep the bird seed. She then took us to the back to show us a large roll of hay for the animals. I cannot confi m whether this is for bedding or to it as it does seem like either oathay/straw.

We did a walk through again and could see that the place was somewhat cleaner . We walked to the donkeys and cattles water bath and saw but was moved but still dirty and empty.

The other baths in the fowl areas had water but it was still dirty with built up. They did clean most of the old hay in the shelter areas and replaced hay at the sheep shelter. I did not see any of the hazardous material like iron plates, plastic, sharp planks, wires etc removed. The old goat climb structure is also broken and rusted and needs to be remived. The scrap yard needs to be seperated from where the animals can go.

They were busy emptying the main pond but it was still extremely dirty.

They filled the pond of water where the tortoises are kept. The main issue with these pond is that because it does not have flooring and is natural, it gets dirty easily and difficult to clean .

Fencing are old and has protruding wires.

To issue a warning for specifics again tomorrow .
