In light of my inspection conducted on the 31st of October 2025, the following concerns were observed and must be rectified by 12th of November 2025, unless stated otherwise.

You are hereby warned that:

1. Upon our inspection, we observed horses being kept in a paddock without adequate protection against the elements (See Animals Protection Act 71 of 1962 Sec 2(1)(b)).

a. Provide adequate shelter for the horses within 30 days.

2. Excess manure was observed inside the horse enclosure where the horses are kept causing parasitic conditions. (See Animals Protection Act 71 of 1962 Sec 2(1)(e)).

a. Ensure to clean the horse enclosure properly from excess manure.

3. We were informed that the horses feed consists out of Lucerne and natural grazing only. (See Animals Protection Act 71 of 1962 Sec 2(1)(c)).

a. Provide a veterinary report stating that this diet is adequate for all the horses.

This warning has been issued in terms of the Society for the Prevention of Cruelty to Animals Act 169 of 1993.

Failure to comply with this warning may render you liable for prosecution under the Animals Protection Act 71 of 1962 and/or Performing Animals Protection Act 24 of 1935.
