We then told her that we are there with a court order and will take the dog if they do not want to surrender. .she got hostile and said that we cannot take the dog. I then told her that we did not want to involve SAPS but she was still obstructive. I then called Wellington SAPS for assistance. She went inside the house with the warrant. A little while later Jevandre came out and said he is getting someone the following day to clean the yard. We explained the same to him and he also refused to give the dog. We could not just take the dog as it is aggressive. We then waited for SAPS to arrive. Whilst waiting Jevandre came out to give Rocco water and food. We then tried convincing him again to hive the dog to is without involving saps. He went inside and came back out again. He then asked for the leash and help us get the dog Rocco. I left a Seizure Notice 09 with Jevandre and he signed it. He claimed agin that it is his fathers dog. We then said they can try and claim the dog within 7 days but have to make an appointment. We loaded Rocco into the vehicle and left.
