Dorothea signed and accepted the warning. Apparently the owner Veenan Waterboel does know about the offence.

We then went to where the grandma stays and explained the seriousness of this to her too and she agreed with everything we said and was aware of the matter.

We told her to let Veenan know whether he wants to sterilize Savannah and left a information pamphlet with Dorothea.

As we left the owner of the farm also spoke to us and was aware of the situation.

It seems like everybody will help each other to keep an eye on St Clair.
