He said its his sons dog and then I explained the definition of a owner to him. He got difficult when his wife Catherine arrived home. We explained the situation to her as well. She said a young guy came down the road with a sword and hit the dog but they did not witness it. The guy went to a local gangsters house named Gys and ahe reprimanded him. They do not want to take action legally. She signed Rexi over and agreed that he needs to be euthanized.

I then issued a warning to:

1) Your dog has been injured since Friday the 31st of January 2025. In future, ensure to provide/seek veterinary assistance immediately as this is a contravention of the Animals Protection Act Sec 2(1)(e).

Catherine signed the warning.
