General Report Comments: I, Elani arrived at the property and met with Silka. She gave me access and explained that they only have thee dogs now as one was hit and killed by a car.

We went to the back yard that was partially cleaned but there were still lots of rubbish , overgrown plants etc and the animals are still infested with ticks. Silka said that the guy who had to clean did not pitch even though there were 3 men present at the time of my visit. I got strict with Silka explaining again why they need to get proper tick and clea treatment, why they need to clean the yarx, that the dogs can die from tick bite fever. I asked again if they want to surrender some of the animals but she refused as they protect the house. O told her they wont be able to protect if they die. I gave her a final warning and explained that they either work together or I will get a court order to remove the animals as they need to take responsibility. She said she will make a plan. I eplained again that the mobile clinic is not far and they can buy everything from there.

She came to the car with me, i gave her dip in.a 2L bottle and a pamphlet and a final warning that she signed stating:

- 1) Your dogs are infested with ticks. Enzure to provide adequate tick and flea treatment within 7 days.
- 2) Clean your yard from rubbish and hazardous material within 7 days.

To follow up and give them more than enough time and recheck next week .
