I issued a final warning to:

1) Ensure to provide Leila with adequate shelter (waterproof roof, flooring, three sided) within 48 hours

2) Ensure to clean Leilas living environment from excess faeces and hazardous material within 48 hours.

Angeline signed the warning and said she will comply. I did inform her that I can take the dog away and this is serious.

I then went to Nolan and saw the living environment of his dogs are still fine. I gave him Revolution Spoton and dewormers to give his dogs. I informed him that I will return in a month's time to see the skin condition of his dogs.
