General Report Comments: I, Elani, arrived at the property, there was a blue bakkie CK37791 and a blue Sentra CJ 50111 in the yard. Willem was at home and I introduced myself.

I saw he had a pitbull and an SPCA dog of which the pitbull was underweight. I told him the concern he received and he claimed that his dog was sick and he treated it recently. I asked if I could see the medication or receipt and he was unable to produce me with that.

We then went inside the back yard. It was dirty with lots of hazardous material and yhe dogs had a big bowl of green drinking water. There was one kennel and a large veranda for the dogs. I then asked Willem about what dog food he gives and he showed me an empty packet of Bobtail food. He then claimed he needs to buy more food later the day. I asked him about his electricity and whether he has the finances to look after his dogs and he claimed he is able to. He kept on asking who complained but I told him I cannot give that information.

I then told him bluntly, if I find any contraventions of the APA that legally as per contract I can take Jock away to show him the seriousness of the matter. He also claimed he feeds his dogs once a day.

I then proceeded to issue a warning to:

- 1) Provide Pablo with dewormer within 3 days.
- 2) Provide adequate food within 3 days because the food was finished when I inspected your premises.
 - Feed twice a day
 - I recommend puppy food for Pablo
 - Dont feed bones, potato peels and pap.
- 3) Ensure their living environment is free from hazardous material within 3 days.
- 4) Ensure to clean their water bowl within 3 days.

He signed the warning and agreed he will fix everything over the weekend.
