General Report Comments: Upon my, Elani, arrival, I noticed Roxy was free roaming and not on a chain. I called out and Andy came to the gate. He chained Roxy up and then allowed me inside so that I can inspect the living conditions of the animals present.

They have complied perfectly by building a running chain, providing piping around the neck of Rocys chain, cleaning the living environment and using the pallet as a bed for Roxy.

I did notice the other dogs to be underweight. I asked to see the food they are feeding. He then called the owners daughter and she brought a 1.75kg Bobtail pack of food down that is meant for all the dogs. I told them this is unacceptable and enough for one dogs feed per day. When asked what they feed, she started by saying potato peels. I reemphasized everything I yold Andy previously on what to feed and what not to feed and told yhem they need to get more food asap and have the option to surrender some of the dogs to us as there are a lot and they need lots of food.

I proceeded to issue a warning to:

- 1) Provide all dogs with adequate food twice a day within 48 hours. Upon my inspection there was only 1.75kg food. (Preferably puppy food)
- 2) You can surrender the dogs over to the spca

*Dont feed potato peels, bones, pap.

Tamlyn Cloete signed and accepted the warning.

To follow up within 48 hours. If they comply, I can help with a kennel and dewormer.
