I noticed a dog at this property that I didnt see on my first visit. This dog named Ranger was emaciated. I asked the kids to get a family member to speak to. They called their grandma and she signed the dog over to the SPCA.

They provided Boster with a running chain and a new collar. However, the running chain still did not work efficiently. Because they tried to comply best they can, we gave them a new vollar for Boster and fixed a swivel to their running chain to make it work properly. We also moved the kennel to where it would provide best shelter on the stoep we also placed the bucket of water next to the kennel and educated them more about keeping the area free from hazardous materials as rusted sheets were found. We then awarded them with dewormer for their dogs.
