I explained what I have achieved and what I would like to suggest. He was friendly and said he is willing to pay half the price of each of his workers animals and gave the manager the task to gather the info on who wants is interested in this. He also said he will take the horse box with animals to us or we can do it in his horse clinic. He also said he will try to speak with the owners of Ark en Siel about this but said they are difficult and very private . I gave him our contct details and said that he must contact us. It also turned out that he wants to adopt Stella and Kai and immediately went to SPCA to apply for them.

I then went to the farm worker houses. I then handed out dog and cat food for everyone who worked with me. I traded the one guy for the chains of his dogs by giving him food and a kennel. He did comply in loosening them again.

Case can be closed and sterilization process can be handled by reception.
