Helena showed me building material her husband bought to raise the front fence. I asked by when they will finish this and she couldnt give me an answer. I then told her thats a long term solution and expensive so this is why I am giving her a short term solution.

I issued a warning to:

1) Provide Roxy with an adequate collar within 19 days (piping around neck, hose, tube).

2) Provide Roxy with a running chain within 19 days.

3) Ensure she always has access to water (place bucket in tyre)

*19 days due to payday the 25th.

She asked me what happens if they do not do what I say which I found interesting. I then told her she can be prosecuted and I will remove the animal. I explained that is why we help and educate before we just take a dog.

She signed the warning. To follow up within 19 days.
