General Report Comments: I, Elani arrived at the farm houses and there were multiple people busy drinking. I asked where the mother dog and pups are and everone showed me to the house on the right looking at it.

At this property they had 10 dogs in total of which one was on a running chain. Rodine tolde me she would like to surrender all of her female dogs which totalled to 7.

I then went to all of the other houses where all of the dogs were free roaming and in good condition.

Except for one house where Bonzo stays. The owner Berenise Pas was not home but Amy Lee Bailey assited me. Bonzo is old and emaciated and had oil on his neck. I educated Amy about this and issued a warning to the owner to:

- 1) Do not use oil as tick and flea treatment. Wash it off.
- 2) Provide Bonzo with adequate food within 72 hours. Feed twice daily, do not feed bones, pap and potato peels.
- 3) Provide dewormer for Bonzo within 72 hours (Prefereably Triworm D, can buy from me R25 a tablet)

Amy lee signed yhe warning and I went back to Rodine who signed 7 dogs over.

I gave dewormer to the remainder of the dogs as she immediately complied. I also handed out information pamphlets to the dog owners.
