She ensures the plants in there are also guinea pig friendly and has clovers grown all over. She does not use this in the winter as it is extremely cold. This is mostly for the summer. She also has playpen walls for when she wants them to roam free in the house.

She uses Dr Karli de Wet as her main veterinarian for them. Her husband is also at home all the time as he cannot work/walk. This is to check up on things. She works as a lecturer and is on sabbatical now and able to take on new guinea pigs.

Her room for the guinea pigs are amazing.
