I then told her that she can show me around and she gave me access to the property.I then walked in and noticed no changes had been made.I also noticed that there was more the 2 dogs(a male and two females).Lulu was one of the females who was limping.I then asked when the yard will be cleaned because they are not making any progress.Ashlene then told me that the person who cleans the garden will be coming today.I then told them that they need to get the dog at the mobile clinic tomorrow otherwise we will need to confiscate if they deny Lulu veterinary treatment.She then understood and agreed to give the message through to Silke and ilze.I then explained that denying veterinary treatment is one of the biggest contrevention of the APA .She then agreed to give the notice to comply to them.I also asked her whether they had bought the bravecto or nexguard but she could not answer me as she claimed she does not know.

Notice to comply 024 was then issued to:

-Ensure to clean the yard of hazardous material and parasitic conditions within 48hours.

-Provide Lulu with medical attention within 48hours as she is limping(can go to mobile clinic).
