General Report Comments: I, Elani went to Wellington SAPS and got assistance from Sgt Bird en Const Ngqongwa. We went to the property and found Angeline Pietersen and her grandson Juwade Pietersen at home. I gave the warrant to her and explained why I was there. She started saying the date on the warrant is wrong as it says 2025 but it is 2022. I called the Sgt Bird and she said the same thing to him. We told her it is 2025. I then decided to ask Juwade what his age is and he said 18. I then decided to talk to him as he is sound of mind. I asked him for Rubin's number and he proceeded to call him. As I waited for this information, Enzo Koopman and Hugh Lewis arrived. Rubin then answered his phone and Juwade gave me the phone to speak to him.

I explained to him that I am there with a warrant and that I am going to seize the dog as he hasn't complied with finishing the shelter and cleaning. He then immediately asked how he can get his dog back. I explained that we will need to meet face to face. He suggested Thursday. I told him to call me closer to the time so we can confirm a time.

Leila was kept on the left side of the house in a small enclosure. The soil and floor was littered with faeces, rubbish and hazardous material. Her kennel did not have a floor yet and she had dirty drinking water available. Enzo caught her with a catch pole and loaded her into the SPCA vehicle whilst Hugh took a video of the entire incident. I then issued a Seizure Warning which Juwade signed. I also gave a copy of Regulation 468 and the court order to him.

I then went to SAPS and obtained OB number 2170/07/2025.

To see whether Rubin makes an appointment Thursday otherwise he has time to claim Leila until next week Monday.
