General Report Comments: I, Elani arrived at Leeuwrivier to do a follow up inspection on the previous warnings issued. As I stopped at the farm, a man came to me known as Mishaan. He told me he got his warning and said he would like to rather surrender his dog over to us. I gave him a leash and he fetched the dog whilst I did my inspection and placed it in my bakkie.

I went to Magrieta Kruger to see whether she has complied and found they have done nothing to help their 2 dogs. I issued a warning to:

- 1) Provide the dogs with adequate food ( puppy food) within 3 days.
- 2) Provide the dogs with adequate Tick and flea Treatment within 3 days.

I explained to Magrieta that if nobody is working and they cannot afford to look after the dogs , they need to surrender them over otherwise, I can get a court order and remove her dogs. I Gave them a water bowl

I noticed another thin dog that belongs to Anita Basiaant. She was not home ,so I issued a warning and Magrieta said she will give it to her.

- 1)Provide your dog with adequate food twice a day within 3 days ( do not feed potato peels, bones and pap, preferably puppy food)
- 2) Provide your dog with dewormer within 3 days.

Magrieta accepted the warning.

I then went to Cindy Faro to see whether they complied. She showed me a bag of Vitagen food that she bought for her dogs. Because she tried to comply, I gave her two water bowls, Karbadustex all of her dogs and dewormed all of her dogs. Her dogs are supposed to gain weight within four weeks.

To do the follow up inspection on Tuesday and take a bag of puppy food and a kennel for Cindy Faro.
