General Report Comments: Hugh and I, Elani arrived at the property. I called out and a woman came to the gate. We explained the situation and then the dogs also came to the front. she immediately asked who complained. She said the owner just quickly went to the shop and will be back soon and we must wait for him and speak to him. We observed both dogs to be emaciated.

After a while the owner arrived at the property. We explained that we received a complaint. Roderick was immediately on defense also asking us who complained and stating he feeds them but they dont want to gain weight. I then explained that we can give advice that should help him as we think feeding is the problem. He then was less hostile and started to listen. He claims to feed them Montego food once a day and he also gives pap and potato peels. We then educated him to rather feed twice a day and not to feed potato peels. We also advised puppy food and proper dewormer.

We also educated him about sterilization which he is not interested in as he breeds with his dogs.

I then issued him with Warning 183 to:

- 1)Lady and Leila are emaciated.
- 2) Provide the dogs with adequate food within 4 days (preferably puppy food, do not feed potato peels, pap and bones)
- 3) Provide dewormer within 4 days for both dogs.

We told him about our mobile clinic and that we sell this there and thus we gave him time till after our mobile clinic to comply. He stays very close to our mobile clinic location.

He signed the warning. To follow up on Wednesday.
