Hugh and I approximately waited for about 10 minutes before deciding to call for him again. He them came to the gate and claimed that he only got paid yesterday and bought an 8 kg bag of shoprite brand food. He said he will only be able to go buy everything today.

I then issued him with a warning again and told him this is serious to:

-You have the option to surrender your dogs to the SPCA.

-Your dogs Lady and Leila are emaciated.

1) As discussed before, ensure to provide the dogs with adequate food (feeding twice a day) within 4 days (preferably puppy food).

2) Provide each dog with dewormer and keep the packaging as proof within 4 days (Triworm D, Milbemax)
