I issued notice to comply 049 to:

- Provide Luna and loot with an adequate running chain within 7 days.
- Provide Luna and Loot with an adequate collar within 7 days.
- Ensure to provide Luna and Loot with adequate potable water immediately(put in a tyre to prevent knockover)
- Clean Luna and Loots living environment within 7 days.
