I observed a male x breed dog on short static chain.I explained to her what would need to be fixed but neighbours of her pushed her to sign over the animal as it would cause problems continually.She then agreed but first she asked that i should attend another complaint on the prison premises.

I went to house 10 where Olivia Padayachiey lives and i found her sitting on a bench in her living room.I asked if i could see her dogs as the complainant claims the living environment of the dogs are not cleaned regularly.I was allowed access through her and i saw two huskys on static chains and one roaming freely outside.The space is large but she says they keep on getting out and that shes planning on fixing the fencing as she gets bonus this month.I saw the huskys had no water and they had adequate shelter but could not get to it.I explained all the contraventions to her but noticed the yard was cleaned recently she just mentioned she cannot move the bucket of faeces as she is waiting for her son.

I issued notice to comply 050 to:

-Provide Heath and Sheeva with an adequate running chain within 7 days.

-Provide Heath and Sheeva with potable water at all times(place in tyre to prevent knockover)

I then left.

I went back to the first property of the initial complaint and the requested they want time to fix things aswell.I at this point had given my last notice to comply and i instructed her how to fix things and that i would follow up again next friday.She understood.
