- I do hereby confirm and undertake that:

- I will notify the Society within forty-eight (48) hours should the animal die or go missing.

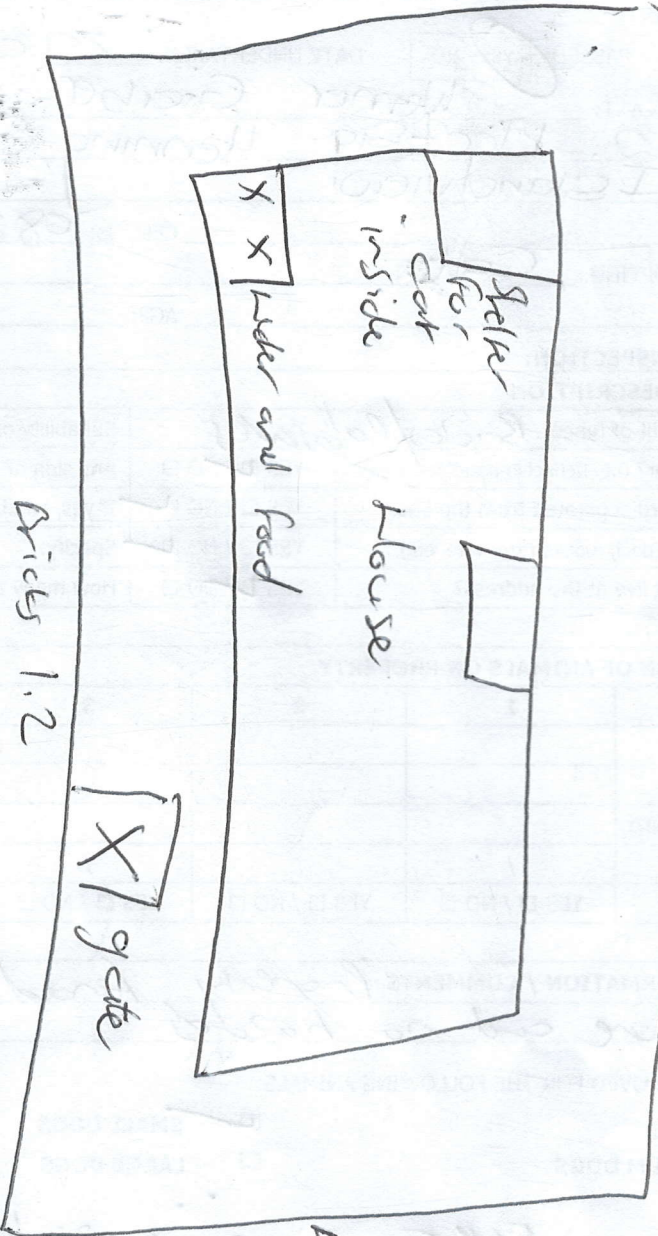

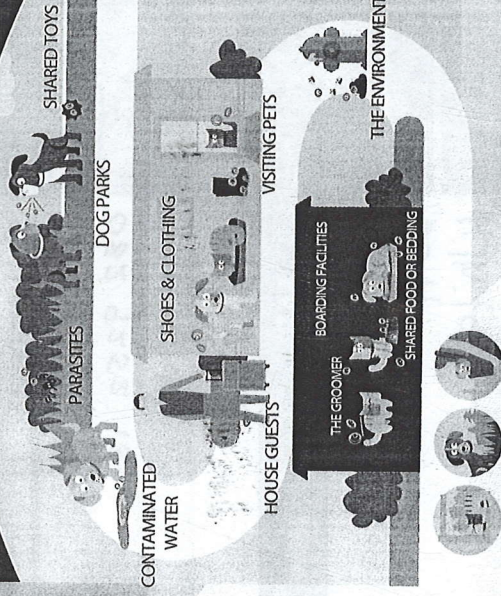
