- 2x Worsie cross, black, male, sterilised
- 1x Pekenese, white, male, not sterilised (zip)
- 1x Terrier, black and tan, male sterilised (diesel)
- 1x Pekenese, white, male, sterilised
- 1x Australian sheep dog, female, sterilised (maya)

The dogs are kept in a fully enclosed property, the fence is about 10 feet heigh and there is mesh fencing. There is no visible areas where the dog's can escape. The dogs are provided with food and enough aounts of water. The owner stated that he owns five dogs and yet on the premises there was a total of eight dogs. He responded to say that he is looking after family members animals during the daytime on a regular bases.
