ACCORDING TO THE MOTHER, MRS LEE, THE INCIDENT HAPPENED EARLIER THE MORNING WHEN THE DOG MANAGED TO SLIP PASSED HER, RAN TO THE NEIGHBOURS'S AND BIT THE COMPLAINANT DOG THROUGH THE FENCING. SHE CLAIMED IT WAS THE FIRST EVER INCIDENCE. SHE THEN CONTACTED HER SON TO ASSIST WHO CLAIMED TO HAVE TEMPORARILY TIED UP THE DOG. THE YARD WAS FOUND TO BE SECURE AND THE OWNER COMMITTED TO UNCHAIN THE DOG. THE COMPLAINANT'S DOG WAS INSPECTED AND WAS FOUND TO HAVE SUFFRED A SUPERFICIAL WOUND REQUIRING JUST CLEANING UP. A WARNING WAS ISSUED TO THE PITBULL OWNER. FOLLOW UP IN 24 HRS.
