General Report Comments: I RETURNED TO THE AREA WITH THREE OTHER INSPECTORS AND MANAGED TO LOCATE THE FARM, WHICH WAS FOUND TO BE NEAR THE RESIDENTIAL HOMES . WE DISCOVERED THAT THE FARM WAS RUN BY 4 INDIVIDUALS, OWNING 28 PIGS IN TOTAL. ON THE FARM WE FOUND A NUMBER OF WELFARE CONCERNS, NAMELY, DIRTY ENCLOSURES, POOR DRAINAGE, DIRTY DRINKING WATER, POOR FLOORING, FEEDING THROUHGS ON THE GROUND BEING DIRTIED WHILE FEEDING. THE OWNERS CLAIMED THAT THEY WERE AWARE OF THE COMPLAINT BY THE RESIDENTS OF THE BAD ODOURS EMINATING FROM THE FARM. THEY MENTIONED THE NEED TO MOVE BUT WERE DELAYED BY PREPARATIONS AT THE NEW LOCATION. A WARNING WAS ISSUED RELATING TO THE WELFARE CONCERNS NOTED AT THE TIME IF THE INSPECTION. A FOLLOW UP DUE IN 7 DAYS. WHILST IN THE AREA, WE WERE ALERTED OF A PERSON KEEPING PIGS IN HER RESIDENTIAL HOME WITH SIMILAR WELFARE CONCERNS. A WARNING WAS ALSO ISSUED TO BE FOLLOWED UP IN 7 DAYS. WE MANAGED TO CONTACT THE LOCAL COUNCILLOR WHO ADMITTED BEING AWARE OF THE ISSUES IN THE POORTJIE AREA. THE ENVIRONMENTAL HEALTH DEPARTMENT WAS ALSO MADE AWARE OF THE RESIDENT'S CONCERNS AND PROMISED TO CONDUCT AN INSPECTION.
