General Report Comments: ARRIVED ON THE PREMISES IN POSSESSION OF A WARRANT ACCOMPANIED BY SENIOR INSPECTOR RAMALATA, FIELD OFFICER JEROME GOVENDER AND TWO MEMBERS OF THE ELDORADO PARK SAPS. I WAS MET BY THE OWNER AT THE ENTRANCE AND I EXPLAINED THE REASON FOR OUR PRESENCE. HE CONSENTED TO THE INSPECTION, WHEREBY A BLACK AND WHITE MALE PITBULL TYPE DOG WAS OBSERVED CHAINED CLOSE TO A WALL TO THE STEEL PALISADE FENCING. THE DOG WAS FOUND TO BE UNDERWEIGHT, WITH SCARRING ON THE FACE AND FRONT LEGS. THE SECOND DOG OBSERVED ON THE PROPERTY A BLACK AND WHITE FEMALE STAFFIE CROSS AND APPERED TO BE PREGNANT. FOUR SMALL BIRDS, FOUND TO BE INDEGENOUS, WERE FOUND PAIRED IN TWO SEPARATE CAGES. ON QUESTIONING THE OWNER, HE DENIED EVER FIGHTING THE DOG AND CLAIMED TO HAVE GOTTEN THE DOG ABOUT TWO WEEKS AGO FROM A PERSON NAMED "CURTLEN" FROM EXTENSION 3 IN THE AREA, BUT CLAIMED NOT TO KNOW HIS PHYSICAL ADDRESS. I ADVISED HIM TO SURRENDER THE MALE DOG AND THE BIRDS WHICH HE RELUCTANTLY AGREED TO. I VERBALLY WARNED HIM THAT HE MAY BE LIABLE FOR PROSECUTION SHOULD WE COME ACROSS INFORMATION LINKING HIM TO ANY INVOLVEMENT WITH DOG FIGHTING. NO FURTHER ACTION TAKEN.
