A warning was issued regarding the concerns & the owner was advised to put the dog on a running wire. The owner was asked about his dog biting someone & he told us that he was reversing his car & the dog managed to go in it. The owner was advised to ensure that the gate is closed properly & that the dog does not roam the streets as it exposes the animal to potential harm. The owner was further educated on the importance of having his dog sterilised.
