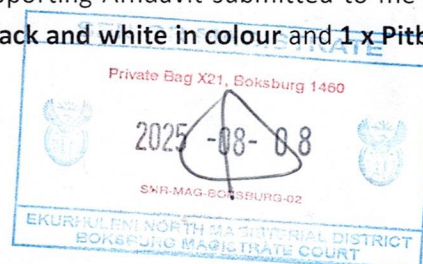

do hereby make oath and state that:

1. I am an adult male Inspector employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906. My certificate of authority for this district is attached marked "A".
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. In terms of Section 3 of the Societies for the Prevention of Cruelty to Animals Act 169 of 1993, the SPCA's objects are *inter alia* to prevent the ill-treatment of animals by promoting their good treatment by man, to promote the interests of societies for the prevention of cruelty to animals and to make cognisance of the application of laws affecting animals and societies and to make representations in connection therewith to the appropriate authority. As part of the means by which it fulfils its objects, the NSPCA appoints inspectors in terms of section 6(1)(c) of that Act.
4. By virtue of my afore-stated position as an officer of the Boksburg SPCA and in giving effect to its objects, particularly to prevent the ill-treatment of animals, I may, where necessary, exercise the powers provided for in terms of section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.
5. I have read and understand the contents of the supporting Affidavit submitted to me by **Field Officer Tshepo Sithole** about **1 x Pitbull type Dog, Black and white in colour** and **1 x Pitbull type**



Dog, Black in colour at No 3A Knights street in Witfield. Notices were issued to the owners to have the dogs treated by **08th August 2025 and to send proof by 12h00** on that day.

6. No communication or proof has been received and I do not believe that the owners have complied with the instructions for treatment.
7. The Boksburg SPCA requires authority to examine the conditions that the animals referred to on this property and have reason to believe that one or more offences listed in **Section 2(1)(a)(e)(q) and (r)** of the Animals Protection Act No 71 of 1962 have been/are being/are likely to be committed. In addition, the Boksburg SPCA, if necessary, may exercise its powers in terms of section 5(1) of the Animals Protection Act No 71 of 1962.
8. I therefore request a warrant in terms of Section 8(1) of the Animals Protection Act 71 of 1962 and Regulation 468 (where appropriate) to examine the conditions in which the aforesaid animal/s are kept in order to ascertain whether or not an offence in terms of Section 2 of the Act has been, is being or is likely to be committed.
9. I request that such warrant authorize the following people to accompany me upon such examination.

- (1) Tshepo Sithole (SPCA Field Officer)
- (2) Jabulani Manchidi (SPCA Field Officer)
- (3) Constable Ebrahim (Boksburg North SAPS)
- (4) Sgt Kgabi (Boksburg North SAPS)

We require assistance from EMPD / SAPS during confiscations for the purpose of ensuring the safety of our staff. Experience shows that the Boksburg SPCA officials are often faced with aggression and violence during these operations and that such a Police presence is essential.



I know and understand the contents of this declaration.

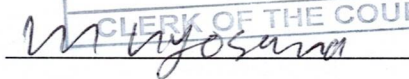

I, the undersigned,

do hereby make oath and state that:

1. I am an adult male Field Officer employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906.
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. On the **06th of August 2025** the Boksburg SPCA received a complaint from a concerned member of the public about dogs that are emaciated and with skin problem. I went to the address, **3A Knight Street (Witfield) Boksburg** to investigate the cruelty complainant.
4. On arrival at the property around **13:10**, I met the owner, **Mr. Peter Coetze** who denied me access to the property for a complete inspection, so I spoke to him through the gate. I managed to see 1 dog s on the property, a **Pit Bull type Male dog (Black in colour)**, He said that's the only dog he has in the property. Later, the very same day the complainant sent me pictures of another dog in the yard, a **Pit bull type dog, (Black and White in colour)** that appeared to have a skin problem/ allergy.
5. A notice to comply was issued to the owner instructing him to provide veterinary treatment for the dog that appeared to have testicular cancer by Friday before 12:00 **08th August 2025**. Failure to provide veterinary treatment will lead to legal actions.
6. I went back to the property to discuss the second dog that appeared to have a skin problem and had been hidden by Mr Coetze. I left a second notice to comply for the black and white pit bull that was sent to us by a complainant for the owner to provide proof of veterinary treatment by 12:00 on the **08th of August 2025**. No contact was made.



7. I have reason to believe that the animals under the ownership of Mr. Peter Coetze have not received urgent medical treatment as instructed and the owner has not made contact or sent veterinary proof as instructed.

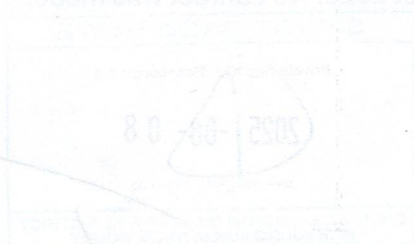


Photo 1 – The hidden dog. Picture sent to me by complainant
