**WARRANT IN TERMS OF SECTION 8(1) OF THE ANIMALS PROTECTION ACT 71 OF 1962,
READ TOGETHER (WHERE APPLICABLE) WITH REGULATION 468 ISSUED IN TERMS OF
SECTION 10(1)(b) AND (c) OF THE AFORESAID ACT**

To: **INSPECTOR RALPH CHIVAVIRO** (Boksburg SPCA)

WHEREAS it appears to me from information provided on oath that there are reasonable grounds to believe that within the Magisterial District of Ekurhuleni, Sub-District Boksburg, there are certain

1 x Pitbull Type Dog (female) (brown & white)
1 x Boerboel Type Cross Breed Dog (female) (tan)

in the possession of / under the control of / upon the premises of and/or upon the person of
Unknown at No. 929 Gwalagwala Street, Vosloorus whose conditions are required to be examined for purposes of determining whether an offence in terms of section 2 of the aforesaid Act has been, is being or is likely to be committed.

This is therefore to authorise you to enter and search the identified premises and direct you to:

1. Examine the animal/s and the conditions in which it/they is/are kept.
2. Take such photographic and/or video footage of such conditions as may be reasonably necessary.
3. Take into custody any and all evidence and/or equipment required for the purposes of a prosecution.
4. If necessary take with you onto the aforesaid property the following person/s:
 - a. **TSHEPO SITHOLE (SPCA FIELD OFFICER)**
 - b. **JABULANI MANCHIDI (SPCA FIELD OFFICER)**
 - c. **BELLA MOLOI (POLICE NO. 707/6 (EMPD CONSTABLE)**
 - d. **STELLA MOKGOTLANE (POLICE NO. 167/7) (EMPD CONSTABLE)**
5. Seize any animal/s and take it/them into your custody if it is reasonably necessary to prevent cruelty to or suffering of such animal/s.
6. Deal with it/them according to law or bring it/them before me to be dealt with according to law.

THIS WARRANT is valid for execution until 18th day of July 2025.

AFFIDAVIT

I, **Tshepo Sithole** ID. **9409035860083** hereby make oath and declare in English as follows: -

1.

I am an adult male employed as a Field Officer by the Societies for the Prevention of Cruelty to Animals Boksburg (Boksburg SPCA) at Cnr Railway and Kruger Street, Boksburg, Johannesburg with contact telephone number/s 011 916 5906.

2.

The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.

3.

In terms of my duties as a Field Officer of the Boksburg SPCA our objectives are to prevent the ill-treatment of animals.

4.

On **16/07/25** We Received a Cruelty Complaint for House **No 929 Gwalagwala street** in **Vosloorus** regarding **2 Dogs** that are malnourished and are without food or water. **Field Officer Jabulani Manchidi** and I went to the address. When we arrived at property, access was granted by **Nontobeka**. We found a **Brown and white female Pitbull** that was surrounded by faeces and chained to a post. She was emaciated, with no access to drinking water, shelter from the weather elements and no food. (see picture 2)

5.

The other dog, a **Tan, Female Cross Boerboel**, was found roaming around freely. She was also emaciated and infested with ticks. Just above her left eye, was a swollen wound that appeared infected and in need of urgent medical attention. (see picture 1)

We then spoke to the person that granted us access (Nontobeka) regarding the two dogs, she said the dogs belong to her uncle who visits occasionally. She gave me his contact details, and I managed to contact him. He claimed that his dogs are well looked after despite the conditions we found them in. He was rude and uncooperative demanding the name of the complainant. I tried to keep the conversation professional and focused on the dogs, but he ended the conversation saying that complainant should feed those dogs.

6.

A **Notice to Comply** was issued, instructing him to:

1. Provide clean drinking water for your two dogs immediately.
2. Unchain your female pit bull since your yard is safe and secured.
3. Provide veterinary treatment for your female cross boerboel and your female Pit bull by 09:00 am 17 July 2025.
4. Provide food for your two dogs by the end of today.
5. Clean your yard for your two dogs daily.
6. You are instructed to phone/ contact Officer Tshepo Sithole on 072 611 7708.



7.

No contact has been made to date. I do not believe that the owner of the dogs is concerned about their welfare as he avoided the topic during my conversation with him and has not made contact as instructed. I am concerned about their living conditions, health and overall welfare.

I know and understand that the contents of this declaration.

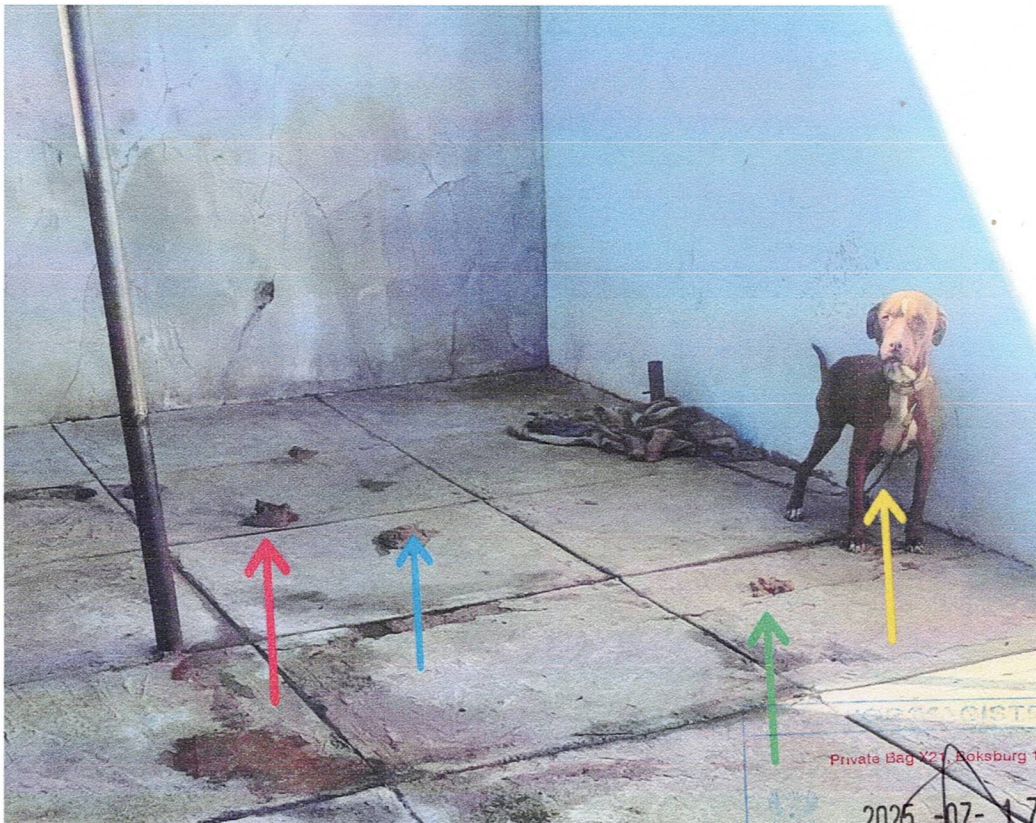

SUPPORTING AFFIDAVIT

I, the undersigned,

do hereby make oath and state that:

1. I am an adult male Inspector employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906. My certificate of authority for this district is attached marked "A".
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. In terms of Section 3 of the Societies for the Prevention of Cruelty to Animals Act 169 of 1993, the SPCA's objects are *inter alia* to prevent the ill-treatment of animals by promoting their good treatment by man, to promote the interests of societies for the prevention of cruelty to animals and to make cognisance of the application of laws affecting animals and societies and to make representations in connection therewith to the appropriate authority. As part of the means by which it fulfils its objects, the NSPCA appoints inspectors in terms of section 6(1)(c) of that Act.
4. By virtue of my afore-stated position as an officer of the Boksburg SPCA and in giving effect to its objects, particularly to prevent the ill-treatment of animals, I may, where necessary, exercise the powers provided for in terms of section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.
5. I have read and understand the contents of the supporting Affidavit submitted to me by **Field Officer Tshepo Sithole** about **1 x Pitbull type, Female dog, Brown and white in colour** and **1 x Boerboel type, cross breed, Female dog, Tan in colour** at **No 929 Gwalagwala street in Vosloorus**. Both dogs are emaciated without provision of food water and shelter. The Pitbull is



chained to a post in a dirty parasitic environment and the Boerboel cross has an injury above its left eye.

6. The Boksburg SPCA requires authority to examine the conditions that the animals referred to on this property and have reason to believe that one or more offences listed in **Section 2(1)(a)(b)(c)(e)(q) and (r)** of the Animals Protection Act No 71 of 1962 have been/are being/are likely to be committed. In addition, the Boksburg SPCA, if necessary, may exercise its powers in terms of section 5(1) of the Animals Protection Act No 71 of 1962.
7. I therefore request a warrant in terms of Section 8(1) of the Animals Protection Act 71 of 1962 and Regulation 468 (where appropriate) to examine the conditions in which the aforesaid animal/s are kept in order to ascertain whether or not an offence in terms of Section 2 of the Act has been, is being or is likely to be committed.
8. I request that such warrant authorize the following people to accompany me upon such examination.

- (1) Tshepo Sithole (SPCA Field Officer)
- (2) Jabulani Manchidi (SPCA Field Officer)
- (3) Bella Moloi (Police No 707/6) (EMPD Constable)
- (4) Stella Mokgotlane (Police 167/7) (EMPD Constable)

We require assistance from EMPD / SAPS during confiscations for the purpose of ensuring the safety of our staff. Experience shows that the Boksburg SPCA officials are often faced with aggression and violence during these operations and that such a Police presence is essential.

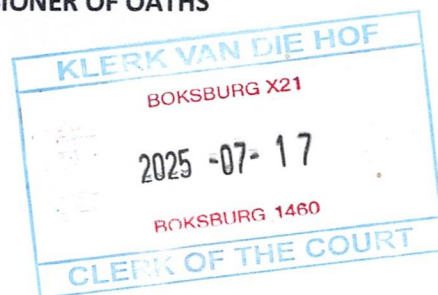
