I am Field officer Jabu from the Boksburg SPCA. i just wanted to give you feed back regarding the cruelty complain you emailed us on 19/08/2025 at 16:05.

I went to the property on 20/08/2025 at 14:11, on arrival 1x male Pitbull, 1x female Pitbull and I found 7 puppies (3 males and 4 Females) that were living in very filthy conditions as you have stated on your cruelty complain.

I gave the owner 24 hours to clean the area where the puppies are kept. I went back on the 21/08/2025 at 15:30 and I found that the area has been cleaned. The mother and father will be sterilised by us as soon as the puppies are done breast feeding. The Dogs do have food and water, the cage is big enough to accommodate all the puppies.
