WHEREAS it appears to me from information provided on oath that there are reasonable grounds to believe that within the Magisterial District of **Ekurhuleni, Sub-District Boksburg** there is/are certain

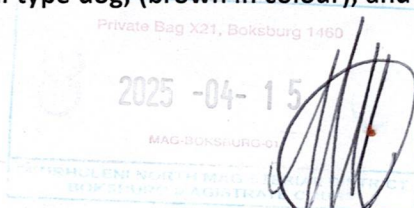

1. I am an adult male Inspector employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906. My certificate of authority for this district is attached marked "A".
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. In terms of Section 3 of the Societies for the Prevention of Cruelty to Animals Act 169 of 1993, the SPCA's objects are *inter alia* to prevent the ill-treatment of animals by promoting their good treatment by man, to promote the interests of societies for the prevention of cruelty to animals and to make cognisance of the application of laws affecting animals and societies and to make representations in connection therewith to the appropriate authority. As part of the means by which it fulfils its objects, the NSPCA appoints inspectors in terms of section 6(1)(c) of that Act.
4. By virtue of my afore-stated position as an officer of the Boksburg SPCA and in giving effect to its objects, particularly to prevent the ill-treatment of animals, I may, where necessary, exercise the powers provided for in terms of section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.
5. I have read and understand the contents of the attached affidavit submitted by **Field Officer Tshepo Sithole** with regards to the animals at **1 Anna Road, Berton Park, Witfield, Boksburg**. As stated in the affidavit, there are 3 animals on the property, **1 x Africanis cross Pitbull type dog, (Black in colour), 1 x Pitbull type dog, (brown in colour), and 1 x Pitbull type puppy, (Brown in colour).**

6. The dogs were engaged in a fight on **12th April 2025** and Field Officer Tshepo Sithole was denied access to the property by the owner, **Mr Mike** when he attended to the complaint after receiving a video of the dogs fighting from a concerned member of the public. A notice to comply was issued to Mr Mike, to have the dogs treated by a vet by **10h00, 13th April 2025**. Officer Sithole returned to the property on **13th April 2025**. A second Notice to comply was issued for the owner to contact Officer Sithole by **15h00** on the day. To date, no contact has been made.
 7. I have viewed the video of the dogs fighting and I am seriously concerned about the dogs featured in it and whether they received Vet treatment after what appears to be a serious dog fight.
 8. The Boksburg SPCA requires authority to examine the conditions that the animals referred to on this property and have reason to believe that one or more offences listed in **Section 2(1)(a)(e)(q) and (r)** of the Animals Protection Act No 71 of 1962 have been/are being/are likely to be committed. In addition, the Boksburg SPCA, if necessary, may exercise its powers in terms of section 5(1) of the Animals Protection Act No 71 of 1962.
 9. I therefore request a warrant in terms of Section 8(1) of the Animals Protection Act 71 of 1962 and Regulation 468 (where appropriate) to examine the conditions in which the aforesaid animal/s are kept in order to ascertain whether or not an offence in terms of Section 2 of the Act has been, is being or is likely to be committed.

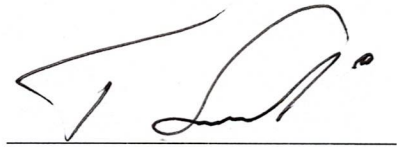
1. I am an adult male Field Officer employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906.
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. On the **12th of April 2025** the Boksburg SPCA received a complaint from a concerned member of the public about dogs that got into a fight while the owners were not on the property. I went to the address, **1 Anna Road Berton Park (Witfield) Boksburg** to investigate after receiving a video of 2 dogs engaged in a fight and a puppy running around the commotion.
4. On arrival at the property around **19h25**, I met the owner, **Mr. Mike** who denied me access to the property for a complete inspection, so I spoke to him through the gate. There were 3 dogs seen on the video that I received, **1 Africanis cross Pitbull type dog (Black in colour), 1 Pitbull type dog, (brown in colour), and 1 Pitbull type puppy (brown in colour)**. All these animals belong to Mr. Mike.
5. A notice to comply was issued to the owner instructing him to provide veterinary treatment for the 2 dogs that got into a fight by tomorrow morning **13th April 2025**. Failure to provide veterinary treatment will lead to legal actions.
6. No contact was made on **13th of April 2025**. I went to the property and was attended to by a caretaker. He informed me that Mike, the owner, had moved one of the dogs to Germiston and had taken the keys with. No access was granted and another notice to comply was issued.

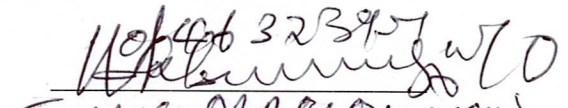
