To: **INSPECTOR RALPH CHIVAVIRO** (Boksburg SPCA)

WHEREAS it appears to me from information provided on oath that there are reasonable grounds to believe that within the Magisterial Ekurhuleni, Sub-District Boksburg there is/are certain

1 x Staffordshire terrier cross breed type dog (Brindle and Black),

1 x Rottweiler cross breed Type Dog (Black and tan)

in the possession of / under the control of / upon the premises of and/or upon the person of **Unknown** at **Unit 8, at 9 Bailey Street in Comet, Boksburg**, whose conditions are required to be examined for purposes of determining whether an offence in terms of section 2 of the aforesaid Act has been, is being or is likely to be committed.

This is therefore to authorise you to enter and search the identified premises and direct you to:

1. Examine the animal/s and the conditions in which it/they is/are kept.
2. Take such photographic and/or video footage of such conditions as may be reasonably necessary.
3. Take into custody any and all evidence and/or equipment required for the purposes of a prosecution.
4. If necessary take with you onto the aforesaid property the following persons:

 - b. **Jabulani Manchidi** (SPCA Cadet Inspector)
 - c. **MJ Ramaube** (SAPS Sargent) (Police NO. 2046109-7)
 - d. **CD Sibanyoni** (SAPS Constable) (Police NO. 72175036)
5. Seize any animal/s and take it/them into your custody if it is reasonably necessary to prevent cruelty to or suffering of such animal/s.
6. Deal with it/them according to law or bring it/them before me to be dealt with according to law.

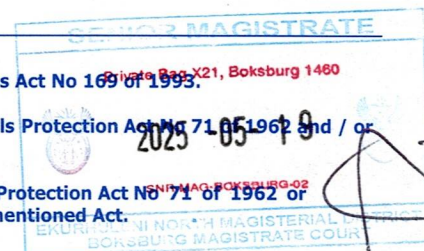
