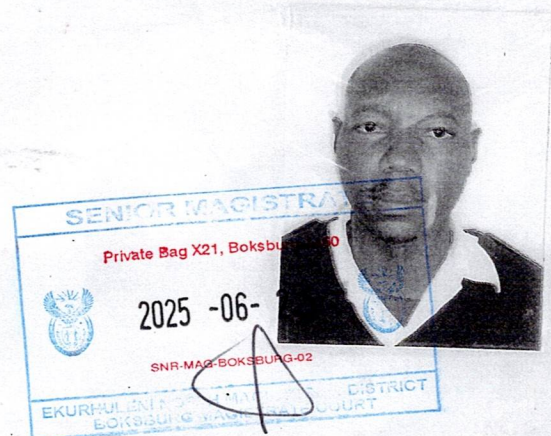

- 1 x Africanis Type Dog (male) (black)

in the possession of / under the control of / upon the premises of and/or upon the person of **Ms Elizabeth Van Eck at No. 1 Naboom Street, Van Dyk Park** whose conditions are required to be examined for purposes of determining whether an offence in terms of section 2 of the aforesaid Act has been, is being or is likely to be committed.

This is therefore to authorise you to enter and search the identified premises and direct you to:

1. Examine the animal/s and the conditions in which it/they is/are kept.
2. Take such photographic and/or video footage of such conditions as may be reasonably necessary.
3. Take into custody any and all evidence and/or equipment required for the purposes of a prosecution.
4. If necessary take with you onto the aforesaid property the following person/s:

 - b. JABULANI MANCHIDI (SPCA FIELD OFFICER)
 - c. SGT LETSOALO (DAWN PARK SAPS)
 - d. CONSTABLE NSIBANE (DAWN PARK SAPS)
5. Seize any animal/s and take it/them into your custody if it is reasonably necessary to prevent cruelty to or suffering of such animal/s.
6. Deal with it/them according to law or bring it/them before me to be dealt with according to law.

I'm Field Officer Jabu from the Boksburg SPCA. Just wanted to give you feedback Regarding the cruelty complaint you have sent to us on 05/06/25. Due to other Cruelties I was busy with plus the weekend, I was only able to attend this cruelty yesterday morning. When I arrived at the 1 Naboom street, I found 2 dogs (Bullterier & Africanis X) that were in a very good condition and were roaming freely in the yard. The home owners were not there but the tenant in the garage was there and she told me there's a 3rd Dog locked in the House.

I gave her a notice to comply so that the owner can contact me, a few hours later the owner did call me and we arranged for a meeting on the 10/06/25 at 12:00 since that when she will be available.

I went there today and saw the Maltese X that was very old, there is nothing wrong with Him apart from him being a very old dog that battles to walk. He had food and water and where he sleeps was very clean.

Apart from the Maltese being old, I didn't find any cruelty or problems on the property.

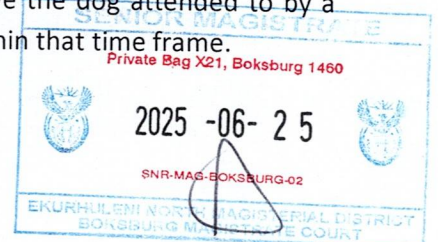

do hereby make oath and state that:

1. I am an adult male Inspector employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906. My certificate of authority for this district is attached marked "A".
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. In terms of Section 3 of the Societies for the Prevention of Cruelty to Animals Act 169 of 1993, the SPCA's objects are *inter alia* to prevent the ill-treatment of animals by promoting their good treatment by man, to promote the interests of societies for the prevention of cruelty to animals and to make cognisance of the application of laws affecting animals and societies and to make representations in connection therewith to the appropriate authority. As part of the means by which it fulfils its objects, the NSPCA appoints inspectors in terms of section 6(1)(c) of that Act.
4. By virtue of my afore-stated position as an officer of the Boksburg SPCA and in giving effect to its objects, particularly to prevent the ill-treatment of animals, I may, where necessary, exercise the powers provided for in terms of section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.
5. On **19th June 2025**, **Field officer Jabulani Manchidi** requested assistance with a cruelty complaint he had attended to at number **1 Naboom Street Van Dyk Park**. The owner **Ms Elizabeth Van Eck**, has a **Maltese type, Female Dog, white in colour**, that appears to be in pain and struggles to walk. I wrote out a warning instructing her to have the dog attended to by a qualified vet within 24 hours and to send me proof of treatment within that time frame.



6. On 20th June 2025 I contacted the husband, **Mr Van Eck** to ask if the dog was attended by a vet and he said that he would not take orders from us. He would decide what he wants to do with the dog. **Officer Manchidi** explained that the owners come to property twice a week as the house does not have electricity. There are 2 other dogs on the premises. A **Bullterrier type, female dog, (Tan and white in Colour)** and an **Africanis type, male dog, (Black in Colour)**
7. I have read and understand the contents of the supporting Affidavit submitted to me by Field Officer Jabulani Manchidi. The owners of the dogs on this property have neglected the daily care for their animals and are content leaving an old dog to suffer without medical treatment as she struggles to walk.
8. The Boksburg SPCA requires authority to examine the conditions that the animals referred to on this property and have reason to believe that one or more offences listed in **Section 2(1)(a)(c)(e)(q) and (r)** of the Animals Protection Act No 71 of 1962 have been/are being/are likely to be committed. In addition, the Boksburg SPCA, if necessary, may exercise its powers in terms of section 5(1) of the Animals Protection Act No 71 of 1962.
9. I therefore request a warrant in terms of Section 8(1) of the Animals Protection Act 71 of 1962 and Regulation 468 (where appropriate) to examine the conditions in which the aforesaid animal/s are kept in order to ascertain whether or not an offence in terms of Section 2 of the Act has been, is being or is likely to be committed.
10. I request that such warrant authorize the following people to accompany me upon such examination.

- (1) Tshepo Sithole (SPCA Field Officer)
(2) Jabulani Manchidi (SPCA Field Officer)
(3) SGT Letsoalo (Dawn Park SAPS)
(4) Constable Nsibande (Dawn Park)

We require assistance from EMPD / SAPS during confiscations for the purpose of ensuring the safety of our staff. Experience shows that the Boksburg SPCA officials are often faced with aggression and violence during these operations and that such a Police presence is essential.

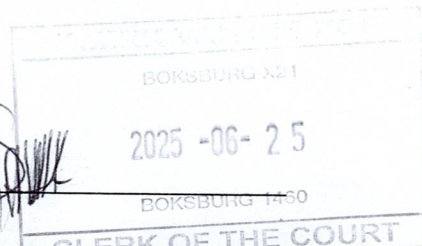

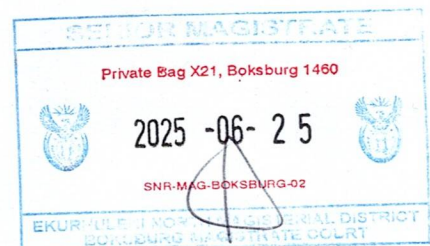

I, **Jabulani Manchidi** ID. **8512085928089** hereby make oath and declare in English as follows: -

1.

I am an adult male employed as a Field Officer by the Societies for the Prevention of Cruelty to Animals Boksburg (Boksburg SPCA) at Cnr Railway and Kruger Street, Boksburg, Johannesburg with contact telephone number/s 011 916 5906.

2.

The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.

3.

In terms of my duties as a Field Officer of the Boksburg SPCA our objectives are to prevent the ill-treatment of animals.

4.

On **05/06/25** We Received a Cruelty Complaint for House **No 1 Naboom street in Van Dyk Park** regarding a dog that is malnourished and is not being given food or water. When I arrived at the address, I found **1 x Bullterrier type, Tan and white, female dog** and **1 x Africanis type, Black, Male dog** that were in a fair condition and were roaming freely in the yard. The homeowners were not there but the tenant in the garage was there and she told me there's a 3rd dog locked in the house.

I gave her a notice to comply so that the owner can contact me, a few hours later the owner did call me and we arranged for a meeting on the **10/06/25 at 12:00** when she will be available.

5.

I went there on the **10/06/25 at 12:00** as arranged and saw the dog that was locked in the house. It was a **Maltese Type, white female dog** that appeared very old. The dog appeared to be in pain as it battled to walk and I believe that it needed medical attention. I asked the owner, Elizabeth Van Eck, if the dog was on any treatment. She said it was not and she would consider getting it treated.

6.

On **19/06/2025**, I made a follow up visit to the property and found nobody home. I had attempted to contact Ms Van Eck without success. **Inspector Ralph Chivaviro** wrote out a warning stating that the owner must take the dog for medical treatment within 24hours and provide proof. The warning was placed on the gate of the property.

20/06/2025, No contact was made with me or Inspector Chivaviro.

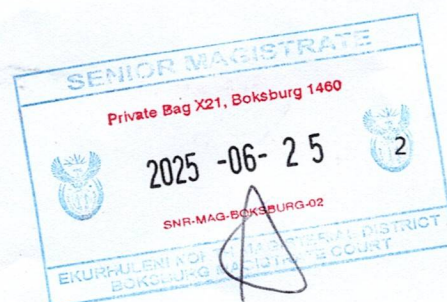
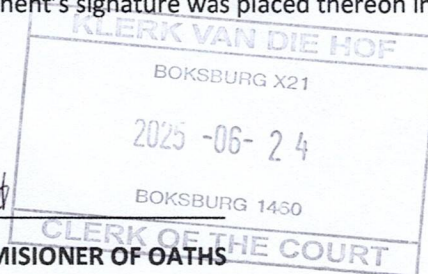
