Failure to comply with this warning may render you liable for prosecution under the Animals Protection Act No 71 of 1962 and / or Performing Animals Protection Act No 24 of 1935.

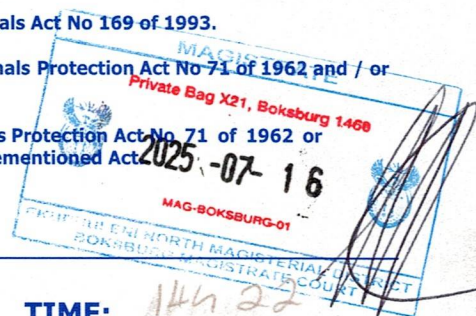

**WARRANT IN TERMS OF SECTION 8(1) OF THE ANIMALS PROTECTION ACT 71 OF 1962,
READ TOGETHER (WHERE APPLICABLE) WITH REGULATION 468 ISSUED IN TERMS OF
SECTION 10(1)(b) AND (c) OF THE AFORESAID ACT**

To: INSPECTOR RALPH CHIVAVIRO (Boksburg SPCA)

WHEREAS it appears to me from information provided on oath that there are reasonable grounds to believe that within the Magisterial District of Ekurhuleni, Sub-District Boksburg, there is a certain

1 x Labrador Type Dog (tan)

in the possession of/under the control of/upon the premises of and/or upon the person of Francois at 8 Ismene Avenue Lilianton, Witfield whose conditions are required to be examined for purposes of determining whether an offence in terms of section 2 of the aforesaid Act has been, is being or is likely to be committed.

This is therefore to authorise you to enter and search the identified premises and direct you to:

1. Examine the animal and the conditions in which it is kept.
2. Take such photographic and/or video footage of such conditions as may be reasonably necessary.
3. Take into custody any and all evidence and/or equipment required for the purposes of a prosecution.
4. If necessary take with you onto the aforesaid property the following person/s:
 - a. TSHEPO SITHOLE (SPCA FIELD OFFICER)
 - b. JABULANI MANCHIDI (SPCA FIELD OFFICER)
 - c. ADRIAAN FOURIE (POLICE NO. 4951027) (EMPD INSPECTOR)
5. Seize animal and take it into your custody if it is reasonably necessary to prevent cruelty to or suffering of such animal.
6. Deal with it according to law or bring it before me to be dealt with according to law.

THIS WARRANT is valid for execution until 17th day of July 2025.

SUPPORTING AFFIDAVIT

I, the undersigned,

do hereby make oath and state that:

1. I am an adult male Inspector employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906. My certificate of authority for this district is attached marked "A".
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. In terms of Section 3 of the Societies for the Prevention of Cruelty to Animals Act 169 of 1993, the SPCA's objects are *inter alia* to prevent the ill-treatment of animals by promoting their good treatment by man, to promote the interests of societies for the prevention of cruelty to animals and to make cognisance of the application of laws affecting animals and societies and to make representations in connection therewith to the appropriate authority. As part of the means by which it fulfils its objects, the NSPCA appoints inspectors in terms of section 6(1)(c) of that Act.
4. By virtue of my afore-stated position as an officer of the Boksburg SPCA and in giving effect to its objects, particularly to prevent the ill-treatment of animals, I may, where necessary, exercise the powers provided for in terms of section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.
5. On 9th July 2025 I went to number 8 Ismene Street Lilianton, Witfield to follow up on the condition of a **Labrador type dog, Tan in colour**, that was struggling to walk normally. On arrival I found the Labrador sitting in the yard next to the front door of the house. The dog managed to



stand up but was struggling to walk and eventually sat down. I left a warning for the owner to urgently contact me and to have the dog treated by a vet within 24 hours, and to send me proof of treatment.

6. No contact was made, and no proof was sent to me. I returned to the property on **11th July 2025** and found a lady that refused to be named on the property. She explained that she was not the owner of the dog and was there to clean the yard. I explained the reason for my visit, and she assisted me with the contact details for the owner **Francois**. I contacted him and he denied receiving my warning. He explained that the dog was old and was on treatment. I asked him to send me proof of treatment or have the dog treated immediately as it appeared to be struggling. He agreed to send me proof of treatment by Monday **14th July 2025**.
7. I contacted him on Monday afternoon and he assured me that he would send the proof to me as soon as he gets home from work. To date, I have not received proof of treatment.
8. I believe I have given Francois reasonable time and opportunities to provide me with proof of treatment for his ailing dog. I suspect that the dog has not been treated and if he has any proof, it does not align with the dog's current condition.
9. The Boksburg SPCA requires authority to examine the conditions that the animal referred to above is kept and has reason to believe that one or more offences listed in **Section 2(1)(a)(e)(q) and (r)** of the Animals Protection Act No 71 of 1962 have been/are being/are likely to be committed. In addition, the Boksburg SPCA, if necessary may exercise its powers in terms of section 5(1) of the Animals Protection Act No 71 of 1962.
10. I therefore request a warrant in terms of Section 8(1) of the Animals Protection Act 71 of 1962 and Regulation 468 (where appropriate) to examine the conditions in which the aforesaid animal/s are kept in order to ascertain whether or not an offence in terms of Section 2 of the Act has been, is being or is likely to be committed.
11. I request that such warrant authorize the following people to accompany me upon such examination.

- (1) Tshepo Sithole (SPCA Field Officer)
- (2) Jabulani Manchidi (SPCA Field Officer)
- (3) Adriaan Fourie (**Police No 4951027**) (EMPD Inspector)

We require assistance from EMPD / SAPS during confiscations for the purpose of ensuring the safety of our staff. Experience shows that the Boksburg SPCA officials are often faced with aggression and violence during these operations and that such a Police presence is essential.



I know and understand the contents of this declaration.

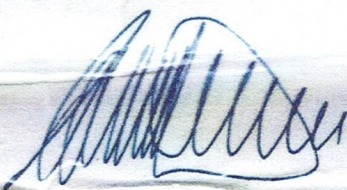
