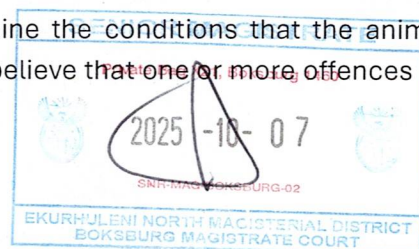

I, the undersigned,

do hereby make oath and state that:

1. I am an adult female Senior Inspector employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906. My certificate of authority for this district is attached marked "A".
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. In terms of Section 3 of the Societies for the Prevention of Cruelty to Animals Act 169 of 1993, the SPCA's objects are *inter alia* to prevent the ill-treatment of animals by promoting their good treatment by man, to promote the interests of societies for the prevention of cruelty to animals and to make cognisance of the application of laws affecting animals and societies and to make representations in connection therewith to the appropriate authority. As part of the means by which it fulfils its objects, the NSPCA appoints inspectors in terms of section 6(1)(c) of that Act.
4. By virtue of my afore-stated position as an officer of the Boksburg SPCA and in giving effect to its objects, particularly to prevent the ill-treatment of animals, I may, where necessary, exercise the powers provided for in terms of section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.
5. I have read the affidavit and seen the photographs of the animals residing at **94 Third Street, Boksburg North**, provided to me by Field Officer Tshepo Sithole.
6. The Boksburg SPCA requires authority to examine the conditions that the animals/s referred to above are kept in as it has reason to believe that one or more offences listed

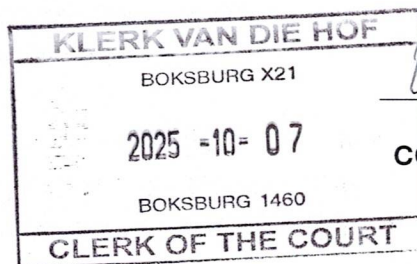
in Section 2(1)(a),(c) and (e) of the Animals Protection Act 71 of 1962 have been/are being/are likely to be committed for the following reasons:

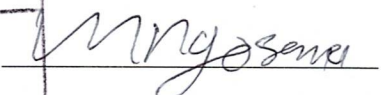
- 6.1 The owner of the Animals is failing to render veterinary treatment and grooming for his/her compromised animals. These being **one cross breed Pitbull, one cross breed Fox Terrier, one cross breed Boxer and one cross breed Maltese Poodle.** This is resulting in the neglect and prolonged suffering of these animals.
7. In addition, the Boksburg SPCA if necessary, may exercise its powers in terms of section 5(1) of the Animals Protection Act 71 of 1962.
8. I therefore request a warrant in terms of section 8(1) of the Animals Protection Act 71 of 1962 and Regulation 468 to examine the conditions in which the aforesaid animal/s are kept in order to ascertain whether or not an offence in terms of section 2 of the Act has been, is being or is likely to be committed.
9. I request that such warrant authorise **Field Officer Tshepo Sithole, Field Officer Jabu Manchidi and Sgt Quinton John Steenberg from the EMPD** to accompany me upon such examination.

**SUPPORTING AFFIDAVIT**

---

I, the undersigned,

06 October 2025

**Tshepo Sithole**

do hereby make oath and state that:

1. I am an adult male Field Officer employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906.
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. On the 2<sup>nd</sup> October 2025, I attended a cruelty complaint at **94 Third Street, Boksburg North**. I had been given the complaint by Inspector Ralph Chivaviro due to him going on annual leave. It had been reported that there were several neglected dogs at the above address.
4. When I arrived at the above address, I could see three dogs from outside the gate. No one was home at the time so I could not enter the property, but I could see that one of the dogs, a black and white cross Pitbull, had an open wound on the side of its body. I issued a notice to comply to the owner of the animals requesting him/her to provide veterinary treatment for the dog that appeared to be injured. I asked for proof of treatment to be provided by 16h00 on the 2<sup>nd</sup> October 2025. (See attached Notice marked **A1**) I received no response from the owner.
5. On the 3<sup>rd</sup> of October I returned to the above property. The owner was not home but there was a domestic worker who came out to greet me. She allowed me onto the property and showed me the animals. I saw 4 dogs at the time of inspection:
  - 1 Cross Africanis type dog (Black and white)
  - 1 Cross Boxer type dog (Black)
  - 1 Cross Pitbull type dog (Black, white and brown)
  - 1 Maltese Poodle (white)



6. The cross Pitbull and the cross Fox Terrier type dogs both had skin conditions.
- The cross Fox Terrier had a terrible skin condition on its back. The fur was falling out and the skin was red and inflamed. I suspect the animal was suffering with a severe flea allergy as I have seen this in dogs before.
  - The cross Pitbull also had wounds on its hind legs.
  - The Maltese poodle had matted fur and was in a state of neglect.
  - The cross Boxer appeared to be under weight.
7. I wrote out a second notice of compliance for the owner and asked the domestic worker if she could give my second notice to the owners of the dogs. (See attached Notice marked **A2**) She agreed. I took a photo of my letter with her cell phone and she forwarded the photo to the owner of the dog, via WhatsApp. I then took photos of the animals (See photos attached marked **A3**). No contact was made over the weekend.
8. I have reason to believe that the animals at 94 Third Street, Boksburg North have not received medical treatment as instructed as the owner has not made contact or sent veterinary proof to date.

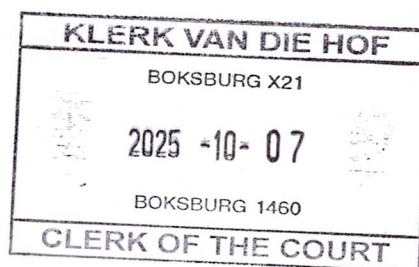

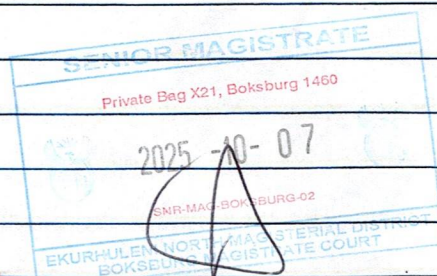
