READ TOGETHER (WHERE APPLICABLE) WITH REGULATION 468 ISSUED IN TERMS OF
SECTION 10(1)(b) AND (c) OF THE AFORESAID ACT**

To: INSPECTOR RALPH CHIVAVIRO (Boksburg SPCA)

WHEREAS it appears to me from information provided on oath that there are reasonable grounds to believe that within the Magisterial District of Ekurhuleni, Sub-District Boksburg, there are certain

in the possession of / under the control of / upon the premises of and/or upon the person of
Unknown at 76 Heineman Street, Sunward Park whose conditions are required to be examined for purposes of determining whether an offence in terms of section 2 of the aforesaid Act has been, is being or is likely to be committed.

This is therefore to authorise you to enter and search the identified premises and direct you to:

1. Examine the animal/s and the conditions in which it/they is/are kept.
2. Take such photographic and/or video footage of such conditions as may be reasonably necessary.
3. Take into custody any and all evidence and/or equipment required for the purposes of a prosecution.
4. If necessary take with you onto the aforesaid property the following person/s:
 - a. SPCA Field Officer Tshepo Sithole
 - b. EMPD Inspector Adriaan Fourie (Police No. 4951027)
5. Seize any animal/s and take it/them into your custody if it is reasonably necessary to prevent cruelty to or suffering of such animal/s.
6. Deal with it/them according to law or bring it/them before me to be dealt with according to law.

THIS WARRANT is valid for execution until 10th day of October 2025.

do hereby make oath and state that:

1. I am an adult male Inspector employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906. My certificate of authority for this district is attached marked "A".
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. In terms of Section 3 of the Societies for the Prevention of Cruelty to Animals Act 169 of 1993, the SPCA's objects are *inter alia* to prevent the ill-treatment of animals by promoting their good treatment by man, to promote the interests of societies for the prevention of cruelty to animals and to make cognisance of the application of laws affecting animals and societies and to make representations in connection therewith to the appropriate authority. As part of the means by which it fulfils its objects, the NSPCA appoints inspectors in terms of section 6(1)(c) of that Act.
4. By virtue of my afore-stated position as an officer of the Boksburg SPCA and in giving effect to its objects, particularly to prevent the ill-treatment of animals, I may, where necessary, exercise the powers provided for in terms of section 8 read with section 5(1) of the Animals Protection Act 71 of 1962 pertaining to the search, seizure and destruction, where necessary of animals. I verily believe that it is necessary for me to make use of the powers provided for by the Animals Protection Act 71 of 1962 by virtue of the following circumstances.
5. I have read and understand the affidavit submitted to me by **Boksburg SPCA Field Officer Tshepo Sithole** about 2 dogs, **1 x Labrador type, Female dog (Brown in colour)** and **1 x Toy Pomeranian type, Male dog (Tan in colour)**, that appear abandoned at **76 Heineman Street, Sunward Park**.

6. We have reason to believe that the dogs on the property have been abandoned as the owners have not responded to notices left at the property requesting contact.
7. I request that such warrant authorize the following people to accompany me upon such examination.

EMPD Inspector Adriaan Fourie, Police no 4951027

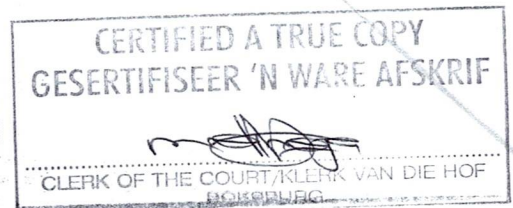
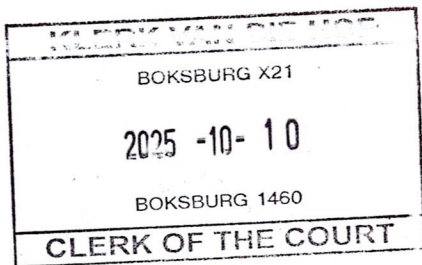
8. We require assistance from the EMPD during confiscations for the purpose of ensuring the safety of our staff. Experience shows that the Boksburg SPCA staff are often faced with aggression and violence during these operations and police presence is essential.

do hereby make oath and state that:

1. I am an adult male Field Officer employed as such by the Boksburg Society for the Prevention of Cruelty to Animals at c/o Kruger and Railway Street, Boksburg East with contact telephone number (011) 916-5906.
2. The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.
3. On the **8th of October 2025**, I attended a cruelty complaint at **76 Heineman street, Sunward Park**. It had been reported that there were several abandoned dogs at the above address.
4. When I arrived at the above address, I could see two dogs from outside the gate. No one was home at the time so I could not enter the property. I could see that the two dogs were hungry I gave them food and water. I then wrote a notice to comply requesting the owner of the animals to contact officer Tshepo Sithole by **10h00 am on the 9th of October 2025**. (See attached Notice marked **A1**) I received no response from the owner.
5. On the **9th of October 2025** I returned to the above property. Found the dogs without any sign of food or water from my view point.
 - **Female Cross Labrador type dog (Brown)**
 - **1 Cross Toy Pomeranian male type dog (Tan)**
6. The cross-Toy Pomeranian appeared to be slightly blind and needs to be examined by a vet. I wrote out a second notice to comply for the owner requesting them to urgently contact officer Tshepo Sithole regarding the welfare of the animals. (See attached notice **A2**). I then took photos of the animals (See photos attached marked **A3**). No contact was made over Wednesday and Thursday.

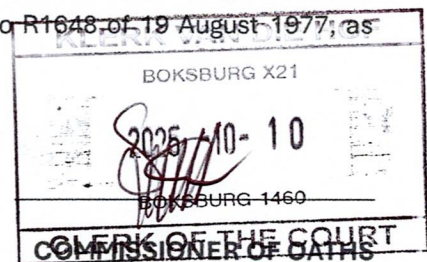
