Your are hereby instructed to:

The conditions in which your animals are living is unacceptable. Ball Python: - You are requested to clean its tank regularly and to provide the correct substrate such as wood chips. The snake needs a hiding box and a heating pad/globe. You may NOT feed live prey as it is illegal to do in terms of the Animals Protection Act 71 of 1962. Rats: - You are advised to surrender the rats to the Boksburg SPCA as you will no longer be feeding live prey to your snake. They are to be provided with fresh water and food and their tank must be kept clean.

Dogshound: - You may not keep your dog confined to a dark room all day, everyday. This is cruel and does not provide for the animal's 5 freedoms.

Tarantula: - Your spider's terrarium must be kept clean and moist.

The substrate must be changed regularly. Peat Moss is recommended.

You are requested to clean the room in which your animals are kept.

The above must be complied with by Friday 14th November 2025.

This notice has been issued in terms of the Society for the Prevention of Cruelty to Animals Act No 169 of 1993 and refers to the Animals Protection Act No 71 of 1962.

WHEREAS it appears to me from information provided on oath that there are reasonable grounds to believe that within the Magisterial District of Ekurhuleni, Sub-District Boksburg, there is a certain

1 x Jack Russel Type Male dog (Tan)

1 x Ball Python (Brown and yellow)

1 x Tarantula Spider

10 x Rats



in the possession of/under the control of/upon the premises of and/or upon the person of Abraham Nel at **44B Bloubos Street, Van Dyk Park** whose conditions are required to be examined for purposes of determining whether an offence in terms of section 2 of the aforesaid Act has been, is being or is likely to be committed.

This is therefore to authorise you to enter and search the identified premises and direct you to:

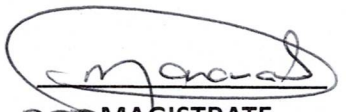
1. Examine the animal and the conditions in which it is kept.
2. Take such photographic and/or video footage of such conditions as may be reasonably necessary.
3. Take into custody any and all evidence and/or equipment required for the purposes of a prosecution.
4. If necessary, take with you onto the aforesaid property the following person/s:

- a) **Boksburg SPCA Cadet Inspector Jabulani Manchidi**
- b) **EMPD Inspector Adriaan Fourie, Police no 4951027**

5. Seize animal and take it into your custody if it is reasonably necessary to prevent cruelty to or suffering of such animal.
6. Deal with it according to law or bring it before me to be dealt with according to law.

THIS WARRANT is valid for execution until 22nd day of November 2025.

7. I request that such warrant authorize the following people to accompany me upon such examination.

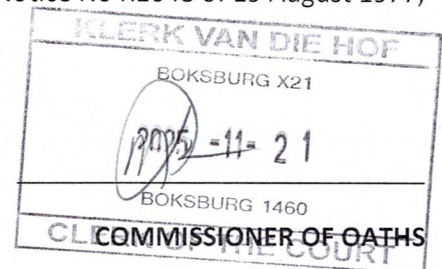

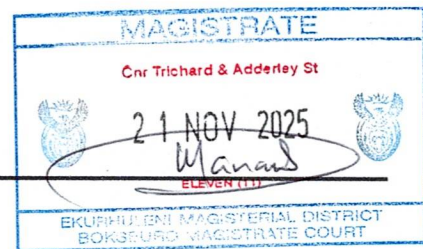

I am an adult male employed as a Field Officer by the Societies for the Prevention of Cruelty to Animals Boksburg (Boksburg SPCA) at Cnr Railway and Kruger Street, Boksburg, Johannesburg with contact telephone number/s 011 916 5906.

The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.

In terms of my duties as a Field Officer of the Boksburg SPCA our objectives are to prevent the ill-treatment of animals.

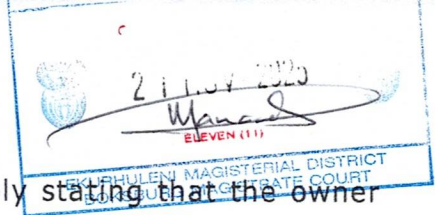
On 11/11/25 We received a cruelty complaint for House **No 44B in Bloubos street in Van Dyk Park** regarding a Dog that is always locked up a tiny room all day on a daily basis. When I arrived at the address, I found **Abraham Nel**, who is the owner of the property and the owner of the Dog, **1 x Jack Russel type cross breed male dog, Tan in colour**, that's always locked up inside the house.

He gave me permission to inspect his property and during my inspection I found a **ball python** that was sleeping in a dirty tank with no heating lamp. See picture 1. Next to the snake tank there were 2 more cages that had **live rats** which are used to feed the snake and in the last tank there was a **Tarantula spider**. Both tanks were also in very bad conditions. See picture 2 & 3.

On **12/11/2025** I delivered a Notice to Comply stating that the owner must clean all the tanks, provide a heating lamp and a hiding box for the snake, surrender the mice to the Boksburg SPCA and buy frozen mice from the pet shop as live feeding of confined predators is cruel to the prey. The owner has not responded to me and does not answer or return my calls. I am concerned about the conditions he is keeping his animals.

I know and understand that the contents of this declaration.

I have no objection to taking the prescribed oath.

I consider the oath to be binding upon my conscience.

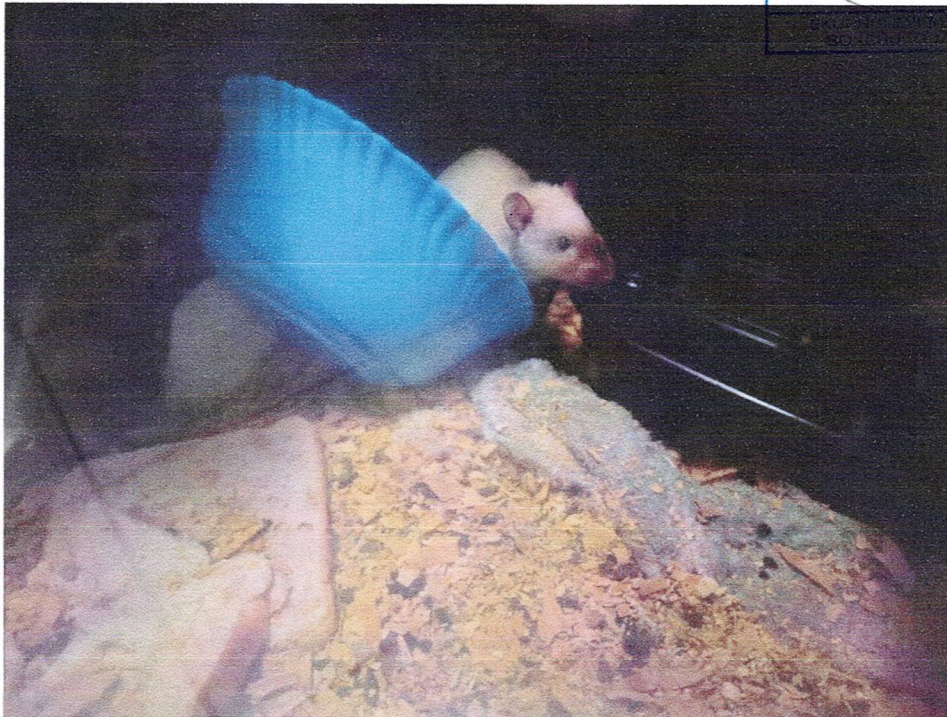


Photo 2 - Ball Python with a live rat in its tank.
