I am Field Officer Jabu from the Boksburg SPCA. just wanted to give you feedback regarding the email you sent to us on 17 January 2026 addressed to the Johannesburg SPCA. i did go to the house opposite 9270 kwena street. On arrival I found Nthabiseng who is the owner of the house. I explained who I am and that I'm there to check on her Animals. She took me to the back and there was 2 dogs in the secured enclosure. Male(black & Tan) and female Africanis (Tan). Both dogs were found in a good condition, they had food and water, and their kennel type enclosure was clean. I did not find anyform of cruelty. Nthabiseng agreed to sterilize both her dogs, starting with the male.

Once the dogs have been sterilised, they wont be able to have puppies again. Thank you for contacting us, hope to hear from you if there's anymore concerns.
