Kwakhona ndithembisa ukuqinisekisa ukuthotyelwa kwezicelo zeSPCA kunye nokuqinisekisa ukuba ndithobela uMthetho woKhuseleko lweZilwanyana wama-71 ka-1962, uMthetho wokugcinwa kwezilwanyana kwisiXeko saseKapa, ka-2021 kunye ne-SANS 1469:2014 Ukuphathwa kwezilwanyana kunye nezibonelelo. kukhuseleko lwemfuyo kwimiboniso, kwiintengiso zefandesi, iindawo zokuthengisa kunye neeponti zemfuyo.

English wording for ease of reference:

*I undertake and commit to the following:*

I understand and agree to the SPCA humanely destroying the said chickens. The SPCA offered for me to take the carcasses which I declined as I will have no use for the carcasses. I give the SPCA permission to dispose of the said carcasses at its discretion.*
- 3. I further undertake to ensure compliance with the requests by the SPCA and to ensure that I comply with the Animals Protection Act 71 of 1962, the City of Cape Town Animal Keeping By Law, 2021 and the SANS 1469:2014 Humane handling and facilities for the protection of livestock at shows, auction sales, vending sites and livestock pounds.*

*Further to the above, I understand that the SPCA reserves the right to open criminal charges against me in terms of the Animals Protection Act 71 of 1962 should I fail to comply with this mutual agreement.*
