You are hereby warned:

As per the inspection conducted at Pollsmoor Correctional Services K9 Unit on 15 February 2023:

1. Upon inspection we observed that faeces and dirt accumulated behind and under the dog houses in the kennels. The drains in the kennels were in an unhygienic state. All areas of the kennel must be properly cleaned and kept clean at all times. Forward proof or feedback to us on how this matter will be rectified by 17:00, on 17 February 2023.
2. Upon inspection we observed that the drains in the kennels did not have a cover that covered the opening. This is a potential danger to the animal and could cause injury. Forward proof or feedback to us on how this matter will be rectified by 17:00, on 17 February 2023.
3. Upon inspection we observed that one of the Rottweiler male dogs named Rocky was due for dental work. This dog must be examined by a Veterinarian. Forward proof or feedback to us on when dental work will be done by 17:00, on 17 February 2023.
4. Upon inspection we observed that one of the German Sheppard male dogs named Racer appeared to have a slight limp/discomfort in his back right leg. He also had what appeared to be a skin condition on his right rump area. This dog must be examined by a Veterinarian. Forward proof or feedback to us in form of a veterinarian report by 17:00, on 22 February 2023.

This warning has been issued in terms of the Society for the Prevention of Cruelty to Animals Act No 169 of 1993.

Failure to comply with this warning may render you liable for prosecution under the Animals Protection Act No 71 of 1962 and / or Performing Animals Protection Amendment Act No 4 of 2016.

Any person who:- obstructs, hinders or resists an officer authorised in terms of the Animals Protection Act No 71 of 1962 or conceals any animal shall be guilty of an offence in terms of Section 8(4) of the aforementioned Act.
