We are sorry that you feel you are being harassed. The SPCA cannot reveal the complainant in this matter and therefore cannot confirm or deny whether the person mentioned in your email is indeed the complainant.

You will have to deal directly with the City's Law Enforcement: Animal Control Unit in this regard, as they have issued you with a notice. The SPCA's findings have no bearing on the duties of the Animal Control Unit, it is two separate matters. Furthermore, the SPCA does not provide reports based on our findings. If we found any contraventions in terms of the Animals Protection Act 71 of 1962, then you would have been issued with a written warning or notice to comply by our Inspectors. If you did not receive any of these, then it is safe to accept that you are not in breach of the Animals Protection Act. With that being said, the City is acting under the Animal Keeping By Law, which is a different piece of legislation governing something different to what the SPCA would look for.

We hope that you can resolve this matter with the City and your neighbour.

I have a voice message from him stating he's not going to stop screaming at my dogs and will continue to lodge C3s.

This is much more I could add about his behavior, but think this gives you an idea of what he's put us through.
