You are hereby warned that:

1. Pig pens

- Some of the pig pens were observed to be flooded, which is not good. Pigs need to have access to a dry and wet area but the wet area should not be excessively wet.

2. Water buckets

- The water buckets were observed to be dirty and unhygienic. You need ensure that the water buckets are cleaned regularly and deep cleaned at least once a week.

3. Water pond

- The water pond of the ducks is very dirty. This needs to be cleaned and maintained, on a regular basis.

4. Disinfectant

- We recommend that disinfectant protocols be implemented. For example; having the public sanitize their hands with F10 spray bottles and the bottom of their feet with F10 foot baths. This will reduce the chance of any disease from entering your farm and also limit the spread of disease.

5. No person shall exhibit or permit to be exhibited any animal of which he is the owner or has the lawful custody, unless such person is the holder of a valid licence in terms of the Performing Animals Protection Act 24 of 1935, as amended in 2016.

Please refer to Section 1 of the Performing Animals Protection Act 24 of 1935:

1. Restriction on exhibition and training of performing animals and use of animals for safeguarding.—No person shall exhibit or train or cause or permit to be exhibited or trained for exhibition any animal of which he is the owner or has the lawful custody or use any animal for safeguarding unless such person is the holder of a licence.
[S. 1 substituted by s. 1 of Act No. 7 of 1991.]

- Should you not be in possession of a valid Performing Animals Protection Act Licence then you are not permitted to exhibit any animal and must forthwith cease to exhibit any such animal to avoid further action and/or criminal prosecution.
