

MUTUAL AGREEMENT

between the

A Cuba

("The owner")

and

The Cape of Good Hope SPCA
("The SPCA")

I, **A Cuba** with ID number 8804041115087, hereby confirm that I am the lawful owner of the Pitbull dog called Betty (Admission number 88914), seized by the SPCA on 21 December 2022 with a court order in terms of the Animals Protection Act 71 of 1962, read together with Regulation 468.

The SPCA has agreed to return Betty into my care on the following conditions set out below:

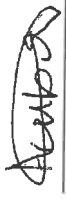
1. I undertake and commit to the following:

- a. I am over the age of eighteen (18) years of age and of sound mind.
- b. I will not leave any animal owned by me with an irresponsible person that is not capable of looking after the animal/s or does not have the time or means to look after the animal. I will ensure that when I have to be absent from my animal/s for longer than 24 hours, I will appoint a reliable, responsible, and trustworthy person of sound mind to ensure that my animal's basic welfare needs are met and that the animal is not abandoned and does not suffer unnecessary during by absence. (*see section 2(1)(p) of the Animals Protection Act 71 of 1962*).
- c. It has been explained to me that I may not keep a dog over the age of 6 months of age unsterilized, as per Section 3 of the Animal Keeping By-Law, 2021 *see section 3 of the City of Cape Town Animal Keeping By Law, 2021*)
- d. I herewith consent to the SPCA microchipping Betty.
- e. An Inspector of the SPCA will be permitted to proactively inspect Betty at my premises at any reasonable time, with my consent, to ensure her welfare and well-being and to ensure compliance in terms of the Animals Protection Act 71 of 1962.

A.

I confirm that I understand that this mutual agreement does not preclude me from any criminal prosecution. This is a voluntary mutual agreement reached between myself and the SPCA to mediate the matter without involving the courts. I understand that the SPCA reserves the right to proceed with criminal charges against me in terms of the Animals Protection Act 71 of 1962 should I fail to comply with this mutual agreement.
