



## **SWORN AFFIDAVIT**

Do hereby make oath and state that:

**1.**

I am an adult female Inspector employed as such by the Cape of Good Hope Society for the Prevention of Cruelty to Animals ("SPCA") at corner of 1st Avenue and First Road, Grassy Park with contact telephone number/s 021 700 4158/9 and email address inspectorate@spca-ct.co.za.

**2.**

The facts contained in this affidavit fall within my personal knowledge unless indicated otherwise or unless it appears so from the context. The facts are also, to the best of my knowledge and belief, both true and correct.

**3.**

On the 25<sup>th</sup> of January 2023, at approximately 12H00, I was dispatched to a farm known as "Peries Foods" located at Rondeberg Road, Philadelphia with GPS co-ordinates 33°36'12.5"S 18°36'07.2"E, to assist my colleague, Inspector Jeffrey Mfini ("Mfini"), with the monitoring of Springbok and Zebra culling.

**4.**

Upon my arrival at the provided address, I observed a vehicle (Toyota Hilux, white, with registration number: B5F 1 WP) approaching me. There were two (2) unidentified men on the back of the vehicle with rifles and my colleague. There were also two unidentified males sitting in the front of the vehicle. (*Refer to photographic evidence "CB – Figure 1"*)

**5.**

The vehicle was driving towards me and then parked at one of the warehouses on the property. One of the men offloaded a carcass of a Springbok. While the other men, including Mfini was approaching me. A man who identified himself as Neil introduced himself. I advised Neil that they will have to forfeit their current operations as they are currently in contravention of the Nature Conservation Ordinances as they are hunting from a vehicle and the property is not fenced accordingly as well. The man understood and agreed to forfeit their operation.

The man advised that they were contracted by an attorney named Mr. George De Beer to cull the Springbok and Zebra on the property and stated that they already shot eleven (11) Springbok for the day. I left the property at approximately 13H00.

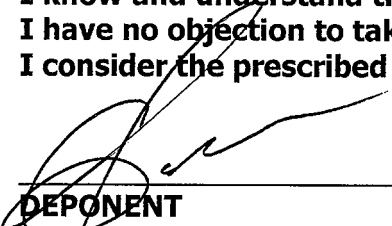

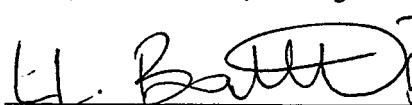
